



**NWRB RESOLUTION NO. 05-0320-B**  
**AMENDMENT ON THE EXTENSION OF VALIDITY OF CONDITIONAL WATER PERMIT DURING THE STATE OF PUBLIC HEALTH EMERGENCY**

The **NATIONAL WATER RESOURCES BOARD** (“the Board”), a government institution, created and existing under Philippines, with office address at 8<sup>th</sup> Floor, NIA Building, EDSA, Quezon City, states:

In a virtual meeting of the Board held on 27 October 2021, the following resolution was approved and confirmed, to wit:

**WHEREAS**, the country has been plagued with the outbreak of the Novel Corona Virus Disease 2019 (COVID-19) that has posed a threat to the lives of the Filipino people and the Philippine economy as well;

**WHEREAS**, on 9 March 2020, President Rodrigo Duterte issued Proclamation No. 922, declaring the country under a State of Public Health Emergency;

**WHEREAS**, on 17 March 2020, President Duterte issued Proclamation No. 929, declaring a State of Calamity throughout the Philippines for a period of six (6) months due to Corona Virus Disease 2019, unless earlier lifted or extended as circumstances may warrant;

**WHEREAS**, on 16 September 2020, President Duterte issued Proclamation No. 1021, extending the period of the State of Calamity throughout the Philippines for a period of one (1) year, effective 13 September 2020 to 12 September 2021, unless earlier lifted or extended as circumstances may warrant;

**WHEREAS**, on 10 September 2021, President Duterte issued Proclamation No. 1218, S. 2021 further extending the period of the State of Calamity throughout the Philippines declared under Proclamation No. 1021, S. 2021 for a period of one (1) year, effective 13 September 2021 to 12 September 2022, unless earlier lifted or extended as circumstances may warrant;

**WHEREAS**, NWRB Resolution No. 05-0320 was issued on 18 March 2020 which provides that Conditional Water Permits due to expire from 15 March to 30 June 2020, including those with granted extensions, shall continue to be valid six (6) months after its/their expiration/s.

**WHEREAS**, NWRB Resolution No. 05-0320-A was issued on 21 October 2020 which provides that all Conditional Water Permits that have expired after 30 June 2020, including those with granted extensions, shall be valid until 30 September 2021, unless otherwise revoked or extended by the Board during the State of Public Health Emergency;

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, that all Conditional Water Permits that have expired after 30 September 2021 including those with granted extensions, shall be valid until 30 September 2022, unless Proclamation No. 1218 S. 2021 is earlier lifted or extended as circumstances may warrant.


