**NWRB RESOLUTION NO. 25-0817**

**AUTHORITY GRANTED TO THE EXECUTIVE DIRECTOR TO ISSUE IDs TO  
DENR DEPUTIZED PERSONNEL**

**WHEREAS**, the NWRB had issued Resolution No. 11-1516 on November 24, 2016 that deputized the DENR Regional Offices to complement DPWH and NIA as the existing deputized agents of the Board;

**WHEREAS**, pursuant to the said Resolution, the WRUS under the Licenses, Patents and Deeds Division shall serve as NWRB's Deputy in the DENR Regional Offices to perform some functions relative to regulation of water use;

**WHEREAS**, as deputized agents, the DENR personnel shall perform the following functions: (1) accept/verify water permit applications; (2) conduct inventory of water users and sources; (3) conduct information, education and communication (IEC) campaign on the Water Code of the Philippines and its Implementing Rules and Regulations (IRR) to key stakeholders in collaboration with NWRB; and (4) conduct re-echo training for PENROs and CENROs and coordination meeting with other deputized agents in the area;

**WHEREAS**, the DENR personnel have undergone capacity building in the 3-day "Hands-on Training for DENR Regional Offices on Certain Functions of Water Use Regulation" conducted by the NWRB that was held on June 27-29, 2017 at the BSA Twin Towers in Mandaluyong City;

**WHEREAS**, one of the issues raised by the participants during the training was the need for an issuance of an ID to be used in the field during the conduct of inventory of water users and sources for identification and security reasons;

**WHEREAS**, consistent with Resolution No. 030-1008 issued by the Board on October 22, 2008 that sets the guidelines for deputation of other agencies, part of the deputation process is the Issuance of Certificate of Deputation/Agent's ID;


**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, to authorize the Executive Director to issue **Certificate of Deputation to DENR Regional Offices and IDs to DENR deputized personnel** for use in the field in the conduct of deputized functions relative to regulation of water use;


**RESOLVED FURTHER**, that use of the Identification Card shall be limited solely to the purpose for which it is issued.

**IN WITNESS THEREOF**, we set our hand this 23<sup>rd</sup> day of August 2017 in the City of Quezon, Philippines.




