



RESOLUTION NO. 26-0222

**EXTENSION OF TIME ON THE SUBMISSION OF ANNUAL REPORT AND
PAYMENT OF SUPERVISION AND REGULATION FEES DURING THE STATE
OF PUBLIC HEALTH EMERGENCY**

The **NATIONAL WATER RESOURCES BOARD** ("the Board"), a government institution created and existing under Presidential Decree No. 424 and Presidential Decree No. 1067, with office address at 8th Floor NIA Bldg., EDSA, Quezon City, states:

In a virtual meeting of the Board held on 16 February 2022, the following resolution was approved and confirmed, to wit:

WHEREAS, the country has been plagued with the outbreak of the Corona Virus Disease 2019 (COVID-19) that has posed a threat to the lives of the Filipino people and the Philippine economy as well;

WHEREAS, on 9 March 2020, President Rodrigo Duterte issued Proclamation No. 922, declaring the country under a State of Public Health Emergency;

WHEREAS, on 17 March 2020, President Duterte issued Proclamation No. 929, declaring a State of Calamity throughout the Philippines for a period of six (6) months due to Corona Virus Disease 2019, unless earlier lifted or extended as circumstances may warrant;

WHEREAS, on 16 September 2020, President Duterte issued Proclamation No. 1021, extending the period of the State of Calamity throughout the Philippines for a period of one (1) year, effective 13 September 2020 to 12 September 2021, unless earlier lifted or extended as circumstances may warrant;

WHEREAS, on 10 September 2021, President Duterte issued Proclamation No. 1218, further extending the period of the State of Calamity throughout the Philippines declared under Proclamation No. 1021, S. 2020 for a period of one (1) year, effective 13 September 2021 to 12 September 2022, unless earlier lifted or extended as circumstances may warrant;

WHEREAS, the submission of Annual Report of all Certificate of Public Convenience (CPC) grantees as per NWRB Resolution No. 30-0619 entitled "Policy Guidelines on the Submission of Annual Report" issued on 19 June 2019, is due on or before May 30th of every year and non-submission of Annual Report entails payment of the penalty fee;

WHEREAS, the collection of Supervision and Regulation Fees of CPC grantees is due every 30th of September of each year;

WHEREAS, foregoing circumstances considered, an extension of time in the submission of Annual Reports as well as in the payment of Supervision and Regulation Fees of all CPC grantees should be provided;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the deadline for submission of Annual Reports shall be extended for two (2) months from 30 May 2022 to 30 July 2022, without the imposition of penalty charges. Failure to submit or non-submission of Annual Report after 30 July 2022 shall be subject to the policy guidelines as stated under NWRB Resolution No. 30-0619 approved on 19 June 2019.

RESOLVED FURTHER, that in case of non-submission of Annual Report on the deadline set, the amount to be billed for Supervision and Regulation Fee shall be based on the documents previously submitted by the CPC grantee without prejudice to reassessment;

RESOLVED FINALLY, that the deadline for payment of Supervision and Regulation Fees shall likewise be extended for two (2) months from 30 September 2022 to 30 November 2022.

This Resolution shall take effect fifteen (15) days after posting on the NWRB website and upon acknowledgment of receipt of the copy thereof by the Office of the National Administrative Register (ONAR).
