NWRB RESOLUTION NO. 27-0817

POLICY GUIDELINES ON THE ISSUANCE OF IDs TO DENR DEPUTIZED PERSONNEL

WHEREAS, the NWRB had issued Resolution No. 11-1516 on November 24, 2016 that deputized the DENR Regional Offices to complement DPWH and NIA as the existing deputized agents of the Board;

WHEREAS, pursuant to the said Resolution, the WRUS under the Licenses, Patents and Deeds Division shall serve as NWRB's Deputy in the DENR Regional Offices to perform some functions relative to regulation of water use;


WHEREAS, as deputized agents, the DENR personnel shall perform the following functions: (1) accept/verify water permit applications; (2) conduct inventory of water users and sources; (3) conduct information, education and communication (IEC) campaign on the Water Code of the Philippines and its Implementing Rules and Regulations (IRR) to key stakeholders in collaboration with NWRB; and (4) conduct re-echo training for PENROs and CENROs and coordination meeting with other deputized agents in the area;


WHEREAS, during the 169th Board Meeting dated August 23, 2017, Resolution No. 25-0817 was passed authorizing the NWRB Executive Director to issue **Certificate of Deputation to DENR Regional Offices and IDs** to DENR deputized personnel;

WHEREAS, in order to have a smooth implementation of the said ID system and for proper identification of NWRB's deputized agents, the following guidelines are hereby recommended:


1. The NWRB shall provide the deputation form to the Regional Offices of DENR which shall be accomplished by the deputized DENR personnel;
2. The DENR Regional Offices shall submit to NWRB the list of deputized DENR personnel with the duly accomplished deputation form.
3. The NWRB shall issue the **Certificate of Deputation to DENR Regional Offices and IDs for DENR Regional personnel** who will perform the delegated functions.
4. The ID shall be valid for one year from the date of issuance but subject for renewal.
5. In case the deputized agent was promoted/resigned/transferred or for any other reasons cannot perform any longer the delegated functions, the DENR-Regional Office shall surrender the ID to NWRB and submit the name and relevant information of the new deputized agent **for the issuance of new IDs.**


